The communiqués did not identify the vetoers, but the Soviet Union later acknowledged its veto in the first case and the United States, in the second. These two vetoed resolutions are entered in this table but because they were only informally attributed, they have not been included in the totals per permanent member.

⁵ One veto was cast in 1955 by China when it was represented at the UN by the Republic of China. All subsequent vetoes have been cast by the People's Republic of China.
